## First Policy Appeal Deemed a Success

Chief and Council had an opportunity last week to engage in the first Policy Appeal since the new Housing Policies were introduced in October. This appeal was filed to dispute a policy which called for a 24-hr notice to remove an animal, concerning an incident involving a tenant's dog and a band member's child.

The appeal process provided a forum where all parties concerned in the dispute were able to provide further information to Chief and Council regarding the circumstances around the incident. After asking questions to clarify what happened, how it happened and what factors were involved, Chief and Council decided to place the tenant on a 30-day review under certain conditions including the use of a leash and muzzle when walking the animal in the residential area of Spuzzum reserve. All parties reported that they felt satisfied with the outcome of the meeting and expressed thanks that this opportunity was available through the appeal process to talk it through and gain a logical workable solution.

Policies are in place to ensure that we have a prescribed process for dealing with common issues and complaints in a fair manner. But we realize that when policies are violated, no two people or situations are exactly alike. The right to file an appeal will allow for every situation to be dealt with on its own merit; taking into consideration any factors around the dispute that the tenants may want to share. We believe that band members will find this process to be extremely fair and will allow for transparent decision-making within the administration of tenancies and housing.

## 2 New By-laws Available for Members to Review

### Spuzzum Community Safety By-law

Spuzzum First Nation felt it was advisable to enact a By-law to provide for the protection of the community, children and the vulnerable on Spuzzum Reserves from violent crime, exposure to illegal drugs and sexual exploitation and abuse.

First and foremost, recognizing that the rights and well-being of the community take priority over the rights of the individual and taking into consideration that the Spuzzum people have historically used banishment to help keep the community safe from threats of violent or dangerous members, the Spuzzum First Nation supports a By-law which would allow Council to initiate the legal process of a restraining order to prevent from entering onto certain areas of Spuzzum Reserves persons who pose a threat to their community, their children and the vulnerable.

### Spuzzum Reserve Disorderly Conduct and Nuisances By-law

The Council of the Spuzzum First Nation Band has drafted a By-law governing the prevention of disorderly conduct and nuisances, entitled the "Spuzzum Reserve Disorderly Conduct and Nuisances By-law". This by-law is to address incidents where someone commits an act of disorderly conduct on Spuzzum reserve, and introduces enforcement measures and penalties for violating this by-law.

"Disorderly conduct" means any act or behaviour, including Fighting; Making or causing unreasonable noise; Using abusive language; Using offensive or indecent gestures or displays; Being drunk; Loitering; Exposing, firing or discharging any gun, pistol or other firearm, or using or threatening to use any other article as a weapon; or Interfering in any manner with the orderly conduct of commercial, administrative, educational, recreational, health care, religious or ceremonial activities on the Reserve, and behavior that disrupts public order on the Reserve, scandalizes the community, or causes public inconvenience, annoyance or alarm. "Nuisance" means any act, activity, or condition, including the abandonment of cars, household appliances or furniture, or parts of cars, household appliances or furniture; the storage of abandoned cars, household appliances or furniture, or parts of cars, household appliances or furniture; the dumping or storage of tires, garbage or other refuse; the burning of tires, grass, garbage, leaves or other refuse; Noise.

Enforcement measures include fines, criminal charges and other possible consequences as outlined in the draft by-law.

## HOUSING

With the approach of the end of the fiscal year on March 31<sup>st</sup>, the Housing department has been wrapping up some of the smaller home maintenance tasks and planning for the new funding year.

Over the winter we had an opportunity to complete most home inspections and develop 3-month Action Plans for each home. The Action Plans identified priorities for each residence and outlined responsibilities for both Tenant and Landlord. Housing has completed almost all of our identified tasks, such as electrical check-ups, furnace repairs, small leaks, winterizing, door repairs, chimney cleaning, gutter care and heat vent cleaning. We have also installed smoke/CO2 detectors in almost all homes.

We want to thank all Tenants for the efforts being made in completing your own home maintenance, such as cleaning yards, repairing broken windows, getting rid of clutter and clearing brush around your house. We would like to ask tenants to continue to work on your home maintenance tasks, particularly in the yards. The warm weather is coming and it will be very nice to see clean pretty yards when we drive around the community.

We are currently working on applications for RRAP grants and AANDC Mould funding. Even people who have CP of their home can apply for the RRAP grant, up to \$16,000 is available for vital repairs and renovations. If your home needs critical repairs please contact Housing before April 5th to be included in the application for the funding, only 6 homes per year will be funded for each band.

## Education

**Bold Eagle Program-** is a unique summer employment program that combines Aboriginal culture and teachings with military training. Bold Eagle is a challenging yet rewarding opportunity that helps to develop valuable skills such as self-confidence, self-discipline, teamwork, time management, respect and fitness to list but a few.
